### Information about the police certificate of conduct

A police certificate of conduct contains information about the person's entries in the police records. The data for this certificate was compiled 15.12.2025 22:46.

The police certificate must only be shown to recipients who may demand a police certificate of conduct by law or regulation.

The police certificate is issued for the following purpose: *Visa, entry, work permits, settlement or residence permits in a foreign country - Ordinary*. The police certificate shows criminal penalties with the limitations imposed by the Police Databases Act § 40.

### Right of appeal

You may complain about the content of the certificate of conduct. The deadline for appealing is three weeks from receiving the police certificate of conduct.

You may submit an appeal digitally through the page "application status" at [www.politiet.no](http://www.politiet.no).

You may also submit a written appeal by post, which is sent to:

Complaints are processed by the Police unit for certificates of conduct. If we don't find basis for changing the certificate, your appeal will be forwarded to The Norwegian Police Directorate for a final decision. The case processing times for appeals are up to one month, plus further processing time with the Norwegian Police Directorate.

We may not submit changes in police certificates that are correctly issued in accordance with the information in the police databases. If you mean that any registries are wrongly registered, and are object of rectification, restriction or erasure, such an inquiry must be sent to The National Criminal Investigation Service (Kripos) cf. the Police Databases Act Section 54 with connected regulation chapter 44.

### Confidentiality

A police certificate contains data from criminal records. We emphasize that any recipient of information based on a criminal records check is subjected to a duty of confidentiality, cf. The Police Databases Act Section 47. Violation of said section is punishable by The Penal Code (2005) Section 209.

### Access to information in the police databases
