1. If a marriage ceremony has not been conducted within the 72-hour period after the date the license was issued, the marriage license expires. [Texas Family Code, Sec. 2.201]
2. The marriage ceremony may not take place during the 72-hour period immediately following the issuance of the marriage license unless: (a) an applicant is a member of the armed forces of the United States and on active duty; or (b) an applicant obtains a written waiver permitting the marriage ceremony to take place during the 72-hour period immediately following the issuance of the marriage license from a judge of a court with jurisdiction in family law cases, a justice of the supreme court, a judge of the court of criminal appeals, a county judge, or a judge of a court of appeals. [Texas Family Code, Sec. 2.204]
3. By my signature, I affirm that a written notice of the online location for the information prepared under Texas Family Code Section 2.010 regarding Acquired Immune Deficiency Syndrome (AIDS) and Human Immunodeficiency Virus (HIV) has been provided to each applicant, as well as notice that a premarital education handbook developed by the Office of the Attorney General under Section 2.014 is available on the Child Support Division's website. 


